**Eligibility:** Must have a cumulative GPA in the top 5% of the student body after the student's second or subsequent semester (completion of at least 24 credits) and attend full-time.

**Academic Persistence Award**

**Eligibility:** Must have initially enrolled in an associate or bachelor degree program and continue through to completion of a bachelor degree on a full-time basis with no interruption in student's education. Transfer students must complete 75% of the credits required for the bachelor's degree at Herzing.

**Adult Learner Scholarship**

**Eligibility:** Must not qualify for the Herzing High School Merit Scholarship or the Henry G. Herzing Scholarship, have 2 written recommendations from employers or educators, submit a qualifying essay of 150 to 300 words as to why the student is pursuing the field of study being applied for and why the student chose Herzing, and demonstrate financial need. Interview required.

**Award:** Determined by the Scholarship Selection Committee each semester. Maximum of \$700 per semester for 4 semesters

**Merit Scholarship**

**Eligibility:** Must be a graduating high school senior, have Herzing entrance scores in the top third of the students accepted by Herzing in the prior year for that particular major and attend full-time in the same year of graduation from high school.

**Champagne Scholarship**

**Eligibility:** Must be classified as an independent student with a \$0 Expected Family Contribution, as determined by the FAFSA; currently be enrolled full-time in a program of study during first academic quarter of attendance (and remain so for each disbursement); make satisfactory academic progress; complete and submit application; and be a U.S. citizen. Prefer-

ence given to working adults.

**Award:** \$3,000 (disbursed in 2 installments —beginning of second and third academic quarters of attendance)

#### **FIRST/ITT Technical Institute Scholarship**

**Eligibility:** Must be a high school junior or senior at time of application; participate in the FIRST Robotics Competition or FIRST Tech Challenge in Alabama during the school year when application is filed; pursue an associate degree; begin program of study by December 31 in year of high school graduation; demonstrate interest in mathematics, science and technology through high school grades; demonstrate leadership and team skills through FIRST team participation; submit application, high school transcript, 500-word essay and a letter of recommendation from FIRST team sponsor.

**Award:** \$9,000; renewable up to 2 years with at least a 3.0 cumulative GPA

#### **President's Scholarship**

**Eligibility:** Must have graduated from an ITT Technical Institute associate degree program with at least a 3.0 cumulative GPA; be enrolled full-time in a bachelor's degree program; have begun work on bachelor's degree after September 8, 2008; contact finance department upon admission to bachelor's program; and demonstrate above-average academic achievement (at least a 3.0 cumulative GPA) during current quarter.


